







FY 2016 Sponsored Programs Total Costs by Major Source





FY 2016 Sponsored Programs Total Cost by College/Unit









FY 2016 Resident Instruction and Other Units Direct Costs



FY 2016 College of Computing Direct Costs



FY 2016 College of Sciences Direct Costs



FY 2016 College of Engineering Direct Costs




FY 2016 Ivan Allen College Direct Costs


Trend Analysis of Graduate Tuition Remission Recoveries



Trend Analysis of Sponsored Programs F&A Cost Recoveries





FY 2016 Resident Instruction and Other Units F&A Costs



FY 2016 College of Computing F&A Costs



FY 2016 College of Sciences F&A Costs




